- The **second** Rope N Run I compete in there will be a **\$20** fee along with all entry fees. I also understand that I am entering as a **ONE TIME** contestant. Non-Member Contestants **WILL NOT** get points from their first Rope N Run as a Non-Member Contestant. **NO POINTS** will be awarded to the contestant for this first Rope N Run, at any time throughout this 2023 season. **NO POINTS** will be counted from the Contestants Second Rope N Run for Year End Results. If I do place in the payout range, I will receive payout for this night's Rope N Run only. I **WILL NOT** be able to sign up for any exhibition runs.
- The **third** Rope N Run I compete in there will be a **\$5** fee along with all entry fees, but I will now become a MEMBER of the Rope N Run. As a member of the Cokeville Rope N Run, my times from this Rope N Run (and any future Rope N Runs I participate in) **WILL BE** used in the overall points. **My times from any previous Rope N Runs will not be used when calculating overall point.**
